

Further improvement in ESG ratings MSCI – Ethifinance

Interparfums^{SA} has announced further improvement in its environmental, social and governance (ESG) ratings assigned by MSCI and Ethifinance. The company holds 12th place worldwide in the second “World’s Best Companies in Sustainable Growth” ranking published by Time magazine.

After improving in 2024, the ESG rating assigned by MSCI to Interparfums^{SA} rose from BBB to A, an upgrade that reflects better performance in several key areas:

- Business ethics, including anti-corruption training for all employees;
- Compensation policy;
- Carbon footprint measurement.

Ethifinance

Interparfums^{SA} once again improved its ESG ranking during the 2025 campaign conducted by Ethifinance ESG Ratings⁽²⁾, an agency that recognizes companies with the best ESG performance. This assessment is based on 140 criteria across four pillars: Environment, Social, Governance and External Stakeholders.

The score achieved in 2025 based on 2024 data was 87/100, up eight points compared to 2024, and reflects the significant efforts made by the company over the past five years against the backdrop of increasingly strict criteria.

Philippe Santi, Executive Vice President, stated: “*This further overall improvement in our extra-financial rating was also reflected in the second “World’s Best Companies in Sustainable Growth” ranking published by Time magazine in December. In this ranking, which recognizes the 500 most exemplary companies in terms of economic growth and environmental commitment from 2022 to 2024, Interparfums rose from 44th place worldwide in 2024 to 12th place worldwide in 2025 and climbed to first place nationally among the 18 French companies selected.*”
